#### NFP094. Any other business and date of next meeting.

1. Commercial to Residential conversions. Using Mill Studios as an example. Can the NP over-ride, reinforce or extend the definitions of employment areas in the District Plan? What is the current state of regulation? Crane Mead as an employment area is badly drafted in the District Plan and doesn't allow for the existing residential buildings and development.

2. Footpaths, Cyclepaths, Bridlepaths and Bridges. Using Crane Mead and Tumbling Bay access as an example. The NP is fundamentally about planning. What can we say to suggest or re-inforce formal path definitions.

3. Air quality. What is the actual goal of doing our own air quality measurements? It seems to me, it should be gathering enough evidence to suggest that HCC, EHDC, Developers or whoever do a formal study. Since they are never going to accept and act on our informal measurements as a basis for real action. Followed by a general policy in the NP.
